This will be a singles handicap tournament, with bracket play finals. We have added a Scratch option, Additional \$10 pay 1:5.
This tournament will be USBC sanctioned and is open to any current certified youth division bowler that is in a youth league. All scholarship monies won will be sent to their USBC S.M.A.R.T. program account. There will be one division, Handicap Division.

ELIGIBILITY: This tournament is open to all USBC certified division bowlers who bowl in youth leagues in the State of Oklahoma. Unattached membership allowed. Each bowler must have average verification or one from the center for multiple bowlers.
ENTRY FEE: Entry fee is $\$ 30$. Fee must accompany entry form. No entries will be accepted without all fees and average verification. Entry fee breakdown is as follows: Lineage $\$ 12.60$, Prize Fund $\$ 15$ and Other Expenses $\$ 2.40$.

AVERAGES: Each Entrant shall use their highest Current USBC Certified league average of 12 games or more in this order. Current 2023-2024 bowling season, Summer USBC certified league or highest recorded average found on USBC web site Bowl.com. Sport shot league averages will be converted to a non sport shot average per USBC conversion chart found on Bowl.com. If no average is available then the bowler will use a 180 average with a possible rerate before finals.
USBC Rule 319a will not apply in this tournament. Verification of average must be attached to entry.
HANDICAP: Handicap will be $90 \%$ of 210
FORMAT: Each bowler will bowl 4 games moving after each game; high series will determine bracket play, high game will be the tie breaker. Bracket play tie breaker will be a $9^{\text {th }}$ and $10^{\text {th }}$ frame roll off. See below for size of bracket and placement. There will be ten (10) minutes of practice on the first pair of lanes only. The tournament will be bowled on a challenge pattern.
CHECK-IN: All bowlers should be checked in no later than fifteen (15) minutes prior to the start of squad
DRESS CODE: Official Oklahoma Youth Jersey, USBC Jersey, collared shirt or bowling branded jersey are preferred. All shirts must have sleeves. No T-shirts, midriffs, low cut or revealing clothing are allowed. Slacks, Jeans, Shorts and Skirts are allowed. Clothing may not have holes, must be hemmed and shorts/skirts must be no shorter than fingertip length. Athletic Shorts and Leggings are not allowed. There will be no sagging clothing or undergarment showing. Bowlers may not wear headwear of any type except when medically necessary. There shall be no personal electronics of any type in the bowler's area or used by bowlers during competition. Bowlers may not wear apparel or use bowling equipment depicting alcohol, tobacco, gambling, illegal substances or inappropriate language/gestures during youth tournament competition. Bowlers will be asked to comply or will be removed from competition. Tournament Directors decision on all matters will be final.

CONDUCT: Each bowler will show good sportsmanship, bowling manners including contact with equipment and furniture, and refrain from using any fowl language or gestures. First offense will be a warning from tournament director; second will be removal from tournament with no refund.
PAYOUT: Payout will be based on the number of bowlers in each division. Payout will be funded to USBC Smart. See payout schedule for exact numbers. Should a tie exist for any of the scholarships, all bowlers involved in a tie will participate equally in the scholarship monies for the places involved.
OTHER RULES AND DISPUTES: All disputes and emergencies will be settled by the Tournament Director and their decision is final unless appeal is made in writing to the Tournament Director
